ORDER:

In the Government Orders first and second read above, the Government have ordered for the apportionment of seats between Government and the management in respect of self-supporting courses run in Government Aided institutions and Self Financing Colleges as follows:-

Sl. No.	Type of Institution	Government Quota	Management Quota
1.	Self-Supporting courses run in Non-Minority Government aided institution	75%	25%
2.	Self-supporting courses run in Minority Government aided institution	50%	50%
3.	Non-Minority un-aided institution	65%	35%
4.	Minority un-aided institution	50%	50%

2. During the academic year 2006-2007, Several Writ Petitions were filed in the High Court of Madras, Chennai as well as in the Madurai Bench challenging the above Government Orders first and second read above. Based on the interim order of

the High Court of Madras dated 20.8.2006 in M.P. No.2 and 3 of 2006, in W.P.No.25232 of 2006, in the Government Order third read above, orders were issued for the apportionment of seats for MBA/MCA as follows for the academic year 2007-2008:-

GOVERNMENT AIDED

Quota	Minority	Non-Minority
Management	50%	10%
Government	50%	90%

3. As the main Writ Petition was pending, during the years, 2008-2009, 2009-2010 and 2010-2011, in the Government Orders fourth, fifth and sixth read above, orders were issued to follow the orders issued in the Government Order third read above with regard to the apportionment of seats in MBA/MCA courses.

4. In the letter seventh read above, the Commissioner of Technical Education has stated that the main W.P.No.25232 of 2006 filed by the National Engineering College Versus State of Tamil Nadu is still pending in the High Court of Madras and the work related to admission to MBA/MCA Degree Programmes for the academic year 2011-2012 has already been started. He has requested the Government to issue necessary orders for the apportionment of seats between Government and Management to be adopted in respect of admission to MBA/MCA Degree programmes in Government Aided Institutions (both Aided and Self-Supporting courses) and Self-Financing Institutions for the academic year 2011-2012.

5. The Government have examined the request of Commissioner of Technical Education, in detail and decided to permit the Commissioner of Technical Education and Director of Collegiate Education to follow the orders issued in the Government Order third read above, with regard to the apportionment of seats in MBA/MCA courses for the academic year 2011-2012 also and order accordingly.
